## President's Message



Dear Centurions,

I must thank all the members for their patience and support during the COVID-19 lockdown and also for following the precautions and guidelines that were put in place during their visits to the Club. Our Hon. Secretary, Mr. E. G. Jaideep, during this period of the COVID-19 lockdown, was on his feet 24x7, keeping a tab on Government orders on one side and ensuring that all SOPs were followed during the lockdown on the other. He also very diligently assisted me in the maintenance, upkeep and repairs of the Club during this period, especially the kitchen, the staff quarters, the staff toilets and many other areas of the Club.

Here, I must make a special mention of three of our members whose philanthropy brought smiles to many of our employees during the difficult days of the COVID-19 lockdown:

- ◆ Mr. Daulat B. Chhabria for giving provision kits to 76 employees, and
- ◆ Mr. Jaswantraj Porwal for giving provision kits to another 20 employees.
- ◆ And our EC member, Mr. M. Krishna Murthy, for giving provisions to the Security and some of the staff who were staying on the premises, during the lockdown.



Mr. Daulat B. Chhabria even extended his magnanimity beyond the walls of Century Club by donating N95 masks, sanitizer bottles and provision kits to 105 police personnel of the Ulsoor Police Station.

In view of the continuous lockdown due to the COVID-19 pandemic, the Executive Committee was constrained to postpone the Annual General Meeting and Elections which was originally scheduled for the 27th of June, 2020, till such time it is conducive to comply with the formalities as required under Rule No. 23 of the Club and its sub-sections, to conduct the Annual General Meeting and the Elections.

And in this regard, the Hon. Secretary, the General Manager and I personally visited the District Registrar of Societies, Bangalore Urban District to explain the situation. And in response to our letter dt.14.5.2020 (see page 4 in this issue), in his reply vide letter dt.21.5.2020 (see page 5 in this issue); he informed us that holding of the Annual General Body Meeting and the Elections to the Executive Committee stands postponed indefinitely until further orders of the Government and that the present Executive Committee will continue till the new Executive Committee is elected.

During this time, the renovation work of the Swimming Pool which was closed since 15th December, 2019 is nearing completion and will be ready for use very shortly, of course, only when the Government gives us permission to reopen the Pool. A lot of credit goes to the Swimming Pool Chairman, Mr. Sandeep Gangadhar who has been relentlessly working to get the Pool ready despite numerous obstacles that kept cropping up in terms of material and labour.

Also, I am very happy to say that, as per the decision of the Executive Committee, the Cover Charges for the months of April and May 2020 have been waived-off and the same will reflect in your May bill.

# Hon. Secretary's Message



Sunday, 15th March 2020... a date that will never get erased from my mind. The lockdown had started and the deadly silence that enveloped the Club that evening, when normally the place would have been bustling, tore through me like nothing ever did before. I yearned for one familiar face and not one could I find. I then realized the profundity of the saying that

“people make a house a home”. Believe me, it is no different with the Club.

To contain the outbreak of COVID-19, the Government had given a directive for a lockdown and the Executive Committee immediately fell in line and unanimously decided to close all the facilities except those of the essential services like, Apollo Pharmacy, Foodworld & Hopcoms. The lockdown continued a couple of weeks at a time, to ensure that people weren't overcome by a sense of insecurity and panic which could have proved disastrous under the given circumstances of an open-ended uncertainty.

To make the best of the lockdown period, the President, Mr. S. Suresh Naidu and I, with the support of the Executive Committee, executed a lot of repairs and maintenance activities, including SOP preparedness, like:

- ◆ Fumigation and cleaning of kitchen, staff room, staff toilets and office block.
- ◆ Medical Grade Sanitizer Dispensers with stand being installed in every section of the Club.
- ◆ Medical Grade Sanitizer Dispensers with foot pumps being installed at the Reception, Veranda, Bar Annex and Health Section.
- ◆ Basic maintenance of all electrical equipment & generators.
- ◆ General cleaning.
- ◆ Maintenance of Garden and watering of plants.
- ◆ Kitchen Chimney Exhaust cleaning and sanitization of the entire Club being done.
- ◆ Renovation of kitchen: Painting, floor & wall tiles repairs, chambers repairs, electrical repairs, etc.
- ◆ Renovation of staff room: Painting, electrical repairs, etc. of Staff Room & Staff Bunkers
- ◆ Renovation of staff toilets.
- ◆ Veranda: POP work of the portico and ceiling from the Reception to the Bar (to prevent the Pigeon menace).

The permission given by the Excise Commissioner, Govt. of Karnataka, to clubs to offload their stock by selling sealed bottles at MRP rates was a boon as we were able to sell more than two thirds of our stock giving us the much needed respite which would have otherwise proved disastrous because of the lack of sales due to the lockdown, that too, during peak summer.

Standard Operating Procedures or SOPs to contain the COVID-19 pandemic have been adopted throughout the Club. Security Staff have been instructed to strictly take the temperatures of all who enter the Club at the gate itself. The entire Club is being disinfected every day. Social distancing markings and SOP posters have been put up everywhere to remind members that we have not yet won the battle against COVID-19. I sincerely thank our EC member, Mr. Santosh Radhakrishna for taking the reins of implementing the SOPs in the Club.

Constant messages and notices, updating members of the constantly changing situation in the Club, based on written Government Orders, were time and again communicated to members by SMS, WhatsApp & email.

Consciously, we have closed the doors to guests and affiliated members, as well as not opened them in the Guest Rooms, as we don't want any unknown or unreliable asymptomatic carrier of COVID-19 diluting our efforts against the Coronavirus. After all, the health of our members is more important than the Club's finances, which can be overcome over a period of time with proper planning and support from the members.

From 2nd June 2020, we opened Badminton, Billiards, Table Tennis, Tennis, Mens & Ladies Beauty Salon, Library, Hopcoms, Apollo Pharmacy, Fabric Spa, Foodworld and Bar (till 30.06.2020 for parcel services only and at MRP rates). Members over 65 years of age were “advised” to stay at home, but understanding their boredom and their need to stretch their muscles, we allowed them at their own risk, but only AFTER installing the AAROGYA SETU app on their mobile and filling the SELF DECLARATION FORM available in their respective sections.

In view of the closure of the Club from 15th March, the time limit for payment of both February and March bills were extended to 15th May 2020 without penalty charges.

I thank all the members for the understanding and support extended to the management during these extraordinary circumstances that we are seeing ourselves in.

In these testing times, all I can ask is please stay safe. Wish you and your family all good health.

This is with reference to the above.



## COVID -19 LOCK DOWN: IMPACT ON ENVIRONMENTAL HEALTH



WHO office in china received the first report that, there is a pneumonia with unknown cause in Wuhan, China on 31st Dec 2019. On 30th Jan 2020 WHO declared the outbreak of Corona virus as a Public Health emergency of international concern by the director general Dr. Tedros Adhanom Ghebreyesus. India received the virus from international travellers.

### SWIMMING POOL:

The long overdue renovation of the Swimming Pool was further aggravated due to a number of technical issues apart from the broken tiles that were causing injuries to the swimmers. So, from mid-January, after establishing a master plan for the renovation, the maintenance and repair works were taken up and now the pool is nearly ready with all the tiles replaced, filtration plant cleaned, new underwater lights fixed, a revamped stoned shower area, a new shoe rack and improvised landscaping. A new qualified coach and support staff will all be ready to welcome us as soon as the pool is inaugurated. Even here, the activities planned for April and May could not be conducted due to the Lockdown.

I trust and pray that I was able to live up to the expectations of the honourable members who had reposed their faith in me and I once again thank the President and the Office Bearers for having given me this opportunity to serve our Club.
